When you call to donate a vehicle to The Kidney Foundation, we require the following:

- VIN or serial number and a description of the vehicle (year, make, model, colour);
- odometer reading;
- telephone number at which to contact you at home and/or business; and,
- legal owner's name and mailing address for the tax receipt.

We give this information to the tow truck driver who will arrange a time to pick up the vehicle.

The driver will also need to know:

- a pickup address for the vehicle;
- if the vehicle still runs; and,
- if the vehicle has any flat tires (so that the driver knows whether to bring a tow truck or a flat bed).

Canada Revenue Agency (CRA) requires that The Kidney Foundation have a Release Form completed and signed by the owner for each vehicle donated in order to issue a tax receipt.

Please complete the Release Form (see below). You may return it to us at fax number 1-866-215-6989 and/or leave it in the front window of the vehicle when it is ready to be picked up. The keys to the vehicle can be left in the ashtray or the glove compartment.

Once we have the information about your vehicle, a time for pickup of the vehicle must be arranged.

In **Regina**, please call ABC Towing directly at 525-3022, referring to the Kidney Car reference number that we will provide when you call us with your information.

In **Saskatoon**, the tow truck operator will contact you to arrange a time to pick up the vehicle.

If the car is scrapped, a tax receipt for **\$75.00** will be issued in about 3-4 months. If the vehicle can pass a safety inspection and/or be re-sold, a tax receipt is issued for the amount for which the vehicle is sold.

An additional amount of \$35.00 will be added to your tax receipt if you drive your vehicle to:

1) **Regina** - Bucks Auto Parts - 3081 Pasqua Street North (Ph: 306-721-7283)

2) **Saskatoon** - Bucks Auto Parts – 4.5 km South West off Valley Road or call for directions. (Ph: 306-249-7278)
