We require the following information to process your request to donate your vehicle to the Kidney Cars Program:

- Description of the vehicle being donated (year, make, model)
- Serial number of the vehicle being donated
- Mileage
- Name/signature of the legal owner
- Pick-up address
- Telephone number where you can be contacted, if necessary (home, work, cell)
- Mailing address of the legal owner (for the income tax receipt)
- Does the vehicle still run?
- Does the vehicle have any flat tires (determines whether tow truck or flat bed is necessary to make the pick-up)

We give this information to the Tow Truck driver who will arrange a time to pick up the vehicle.

It is necessary that a Release (see next page) be completed and signed by the owner of each vehicle donated in order to process the donation(s). You may email the release or fax it to 975-2645 or leave it in the front window of the vehicle to be picked up. The keys to the car can be left in the ashtray or the glove compartment.

Thank You!

- ◆ If the car is scrapped, a tax receipt for **\$125.00** is issued, usually within 6-8 weeks.
- ◆ If the car is brought to our yard at Bucks Auto, 1550 Springfield Rd, (call 925-7270 for their hours), an **additional \$40.00** is added to your receipt.
- ◆ If the vehicle can be resold, a tax receipt will be forwarded once the transaction is complete; this may take up to 3-4 months, as we will make every attempt to get the best price possible for the vehicle.
- ◆ Revenue raised through this program enables The Kidney Foundation of Canada to provide local patient services and education initiatives in our province, as well as fund research.
